The student agrees to pay B Safe Driving School, LLC \$300.00 cash, check, or money order, at the beginning of or before the first class for the Segment 1 Driver Education course listed. A \$25.00 fee will be charged for any non-sufficient fund check. B Safe Driving School, LLC will provide a minimum of 24 hours of classroom instruction, 6 hours of behind-the-wheel (BTW) instruction, and 4 hours of observation time in a dual controlled automobile, fully insured, covering each student enrolled in the program. Classroom instruction must be a minimum of 3 weeks in length. BTW instruction must be completed no later than 3 weeks after the classroom instruction has been completed. The student must be at least 14 years/8 months of age by the first day of class (verification by birth certificate required). Students must complete all assignments in order to complete the course. Students must receive a score of 70% or better to pass the STATE TEST.

NOTICE- This provider is required to be certified by the Secretary of State. If you have any complaint which you cannot settle with this provider, write: Michigan Department of State, Driver Programs Division, Lansing, MI 48918. Completion of driver education instruction does not guarantee qualification for a driver license.

Missed Class/Drive Policy: You must attend 24 hours of classroom instruction, 6 hours of BTW instruction, and 4 hours of observation time to complete the Segment 1 course. Any missed drives when the instructor was **not** contacted at least 4 hours in advance will be rescheduled at a cost of \$25.00 per drive. Any missed classes will be made up at the next Segment 1 class, starting date _____.

Student Behavior: Students are not allowed to be anywhere in the building except the immediate hallway, restroom, and classroom area. Any damage caused by a student to the property, building, or grounds will result in the student being dropped from class immediately and no refund given. Any payment necessary for the damage will be the responsibility of the student and the parent/guardian signed below.

In the event that the student cannot take or complete the driver education program, the refund policy is as follows:

1. Refund of the tuition minus a \$25.00 fee if the student withdraws before the first class.
2. Dropping or being dismissed from the program after completion of the first class, no refund will be given.
