For a student to take part in Segment 2, the student must have completed a minimum of 30 hours of driving, including 2 hours at night, with a licensed parent, guardian, or parent designee, on a level 1 license, which has been held for not less than 90 days. B Safe Driving School, LLC will provide 6 hours classroom instruction. The student must complete classwork and pass the State Test with 70% or better in order to complete the Segment 2 course.

Completion of driver education instruction does not guarantee qualification for a driver license.**

**Missed Class Policy:** You must attend 6 hours of classroom instruction to complete the Segment 2 course. B Safe Driving School, LLC will offer a make-up class, if necessary, at a cost of \$10.00 per class.

**Student Behavior:** Students are not allowed to be anywhere in the building except the immediate hallway, restroom, and classroom area. Any damage caused by a student to the property, building, or grounds will result in the student being dropped from the class immediately and no refund given. Any payment necessary for the damage will be the responsibility of the student and the parent/guardian signed below.

**In the event that a student cannot complete the driver education program, the refund policy is as follows:** Dropping or being dismissed from the program after completion of the first class, no refund will be given.
